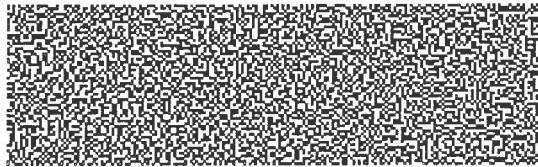
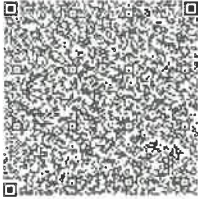

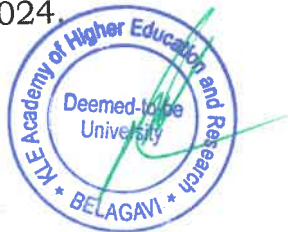

KAHER is a deemed to be University established U/s 3 of the UGC Act 1956. It has 11 constituent units under its ambit providing quality health education in the field of Medicine, pharmacy, nursing, homeopathy, Ayurveda, physiotherapy and allied course. KAHER's College of Nursing Sciences is a constituent unit of KAHER providing Diploma, UG and PG in Nursing Sciences.

AJINORAH is a Limited Liability Partnership firm having 3 partners. AJINORAH institutions is the flagship educational arm of AJINORAH GLOBAL VENTURES founded for providing superior quality education and offers various entry courses required for foreign education and employment like, OET, IELTS, MOH, DHA etc., It has 8 full fledged training centers and 51 other centres across India.



AJINORAH is desirous of providing OET (Occupational English Test) to address the specific English language requirements of the healthcare sector. OET assesses the language proficiency of health care professionals who aim to practice in an English speaking environment. training to the staff nurse or nursing students of KAHER college Nursing. KAHER is also willing to provide the necessary platform. Hence this MOU.

NOW THIS MOU WITNESSTH AS UNDER:

1. AJINORAH shall be providing 2 months Onsite OET (Occupational English Test) training for the staff nurses and nursing students.
2. AJINORAH shall depute experienced and expert trainees at the premises of KAHER to provide training.
3. Classes will be schedules as two batches according to duty shift or class timing. AJINORAH shall provide the course material. KAHER shall not use or provide the study materials of AJINORAH to third party without the prior written permission of AJINORAH.
4. AJINORAH shall advertise the programme and KAHER shall assist in the same.
5. There shall be a minimum of 30 candidates in each Batch.
6. The Course Fee Structure shall be as below

Sl. No.	Course	Fee Structure	Duration
1.	OET Onsite Training	Rs. 15,000/- per candidate	2 months

Note: candidates can extend the duration with an extra payment of Rs. 5,000/- per month If Required Entire fee shall be collected by Ajinorah upfront.



7. AJINORAH shall pay 10% of the course fee paid by the students as referral charges at the end of the course, to KAHER Institute of Nursing as referral charges.
8. KAHER shall provide the necessary infrastructure like classrooms, computer, infrastructure etc.,
9. KAHER shall provide accommodation and food to the trainers at the cost of AJINORAH.
10. AJINORAH shall also assist in exam registration. Separate fee shall be charged for assisting the students for registering them for the examination. In case of successful candidates AJINORAH shall assist for documentation and recruitment process for overseas placements.
11. The candidates are required to write CBT exam, for which the training will be provided by AJINORAH. The Fee for CBT Exam training per candidate shall be Rs.5000.

Duration and Termination of the MoU

1. *Validity of MoU:* The MOU shall be effective w.e.f. 10.01.2024 and shall remain valid till for a period of 2 years i.e till 09.01.2026 and thereafter can be renewed by written mutual consent.
2. This MoU may be amended at any time by written mutual consent.
3. This MoU may be terminated by either party by the provision of written notice of termination not less than 1 month prior to the desired termination date. However, both parties agree that all continuing obligations to students, staff, funding bodies or other entities are met in full, subsequent to the notice of termination.
4. There will be no financial obligations on both the parties under this MoU.

In case of any conflicts arising between the parties with regard to this MOU the decision of the Chancellor, Board of Management, KAHER shall be final.
